4 TROUBLE REPORTS

There are 2 Trouble Reports fixed in this release:

4.1 TR 51 Quotation mark causes problem when exporting to Excel/CSV

In SAM 2.5 and earlier, using the quotationmark (") character in the commentfield makes the export to excel fail. This has been corrected in SAM 2.6.

4.2 TR 52 Cabinet position length problem

In SAM 2.5 and earlier, scanning a Cabinet Position longer than 15 characters makes the import fail with a generic errormessage. In SAM 2.6 the user will be informed about the Cabin Position field being to long and makes it possible to correct it manually.

5.1 CR 74 Cleanup rules regarding moving of equipment between sites

The original text on this CR was like this "There is a timeconsuming limitation in the current SAM, if only one asset in a large complete structure belongs to another TestOrganization the whole structure will fail when trying to save it in SAM and a lot of work is spoiled. By adding the possibility to remove the failing asset(s) the work of scanning the structures will not be spoiled. "

The solution was discussed with several representatives on ETE before the final solution could be settled.

In SAM 2.6 it's possible to force an owner transfer on assets in status VOID or REMOVED FROM ETE when they appear in a scanned import even if they do not belong to your TestOrganization. When an owner transfer has been activated the affected asset will become in status ACTIVE.

For all assets regardless of status it's now possible to view "Owner information" (contactinformation for its current TestOrganizatn). By "Owner information" always available it's hopefully much easier to get in contact with the owner and faster to trigger a normal owner transfer in case of an asset appearing on "wrong TestOrganization".

5.2 CR 87 Additional search options

To further improve the information and search ability of the SAM application the following changes have been done:

- 1) A new "Support Expiry Date" has been added on the SAM individual record. "Support Expiry Date" has also been added to the 'Advanced Search Criteria' options in the search results page.
- 2) The advanced search criteria "Listed Sites" functionality has been extended to support wildcard searches. This can be combined with the commaseparated syntax.
For example:
CH/*, CR/*
- 3) A "Listed Test Organization"-functionality is also implemented in the advanced search with similar behavior as "Listed Sites".
